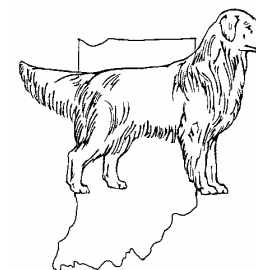

The TDX test is for dogs that have completed a TD Title. The TDX test will be limited to (6) Golden Retrievers. Note: if the limit for entries is not reached in Golden's, other breeds may enter using the following draw procedure. Draw (1) all Golden's without a TDX title; Draw (2) all Golden's with a TDX title; Draw (3) all other breeds without a TDX title; Draw (4) all other breeds with a TDX title. An exhibitor may enter more than one dog. There will be no actual scores for the TDX Test, but the dog will be rated "Passed" or "Failed" and a TDX certificate will be issued by the American Kennel Club confirming all dogs rated "Passed".

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Entry fee for the TDX test is \$110.00 (includes \$0.50 for AKC recording fee and \$1.50 for the AKC event service fee) made payable to White River Golden Retriever Club in US funds. A recording fee of \$0.50 and an event service fee of \$1.50 will be required for each dog entered at any licensed or member club show, or obedience trial, or tracking test. These fees are to be collected by the show-giving club and paid to the American Kennel Club. .

Entries cannot be accepted, canceled, altered or substituted after the entries close with the Tracking Secretary, Janet Ripley.

**The tracking test will be limited to 6 TDX dogs.**

Bitches in season will be allowed to run in this test as allowed in AKC Tracking Rules, Chapter 2. In accordance with the AKC Obedience Regulations (AKC Rules, Chapter 1, Section 26a) entries in this TDX test shall be accepted up until the official closing date, even though the advertised limit has been reached.

The entry participation drawing will be held at the Tracking Secretary's home on October 29, 2009 at 7:00 p.m. to determine which entries will participate in the tests. This drawing shall be conducted in accord with the above procedure. When the advertised limited has been drawn, all remaining entries, subject to the same preference set for above, shall be similarly drawn and assigned a position on the alternate list. The Tracking Secretary shall then notify all entries of the results of the draw. No entry fee will be refunded, except that of an alternate who does not participate and whose entry fee will be refunded within 7 days following the test.

In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the Tracking Secretary to determine if alternates are present, and to determine, by the position on the Alternate list, which of the alternates shall participate.

The assignment of dogs to the tracks, by the drawing of lots, is the responsibility of the judges.
