ENTRIES CLOSE: 7:00 EDT on Wednesday, September 12, 2018 at the address of the test secretary, after which LRWC, GRCA WC/WCX entries cannot be accepted, cancelled or substituted. NO EXCEPTIONS.

SCRATCHES: Refunds will be made for sickness, injury, death or bitches in season.

Notice must be given to the event secretary prior to the start of the test and a veterinarian's letter on letterhead must be sent to WRGRC within one week of the test date. **Bitches in season are NOT allowed on the test grounds.**

JUDGES AND TESTS TO BE JUDGED:

Purpose and Certifications of the two breed tests.

“The Labrador Retriever WC program provides a way for Labrador owners to experience and develop an appreciation for the natural working abilities of their dogs without the lengthy and expensive commitment the competitive performance events require.” From the LRC, Inc. Working Certificate Program Application Form

The Golden Retriever and Flat-Coated WC/WCX tests are designed to test the working ability of Golden and Flat-Coated retrievers and will be conducted in accordance with the AKC Field Trial rules as modified by the GRCA and FCRSA. Golden will be run under the rules set forth by the GRCA while Flat-coats will be run under the rules set forth by the FCRSA. All A.K.C. retriever breeds, Irish Water Spaniels and Standard Poodles are welcome to enter. However, only Golden and Flat-Coated Retrievers will qualify for certification under these rules. Golden and Flat-Coated Retrievers meeting the test requirements will automatically have their pass recorded with their respective national organization and will subsequently receive a title certification from either GRCA or FCRSA. All dogs entered, will receive a duck band. All dogs, regardless of breed (recognized by A.K.C.), that qualify under the rules will receive a card of congratulations from GRCA and a memento.
