White River Golden Retriever Club assumes no responsibility for any loss, damage or injury sustained by exhibitor, handlers or to any of their dogs or property and further assumes no responsibility for injury to children not under the control of their parents or guardians. All dogs must be on leash or crated at all times. (Reference AKC Tracking Regulations Chapter 1, Section 17.)

The VST test is for dogs that have completed a TD or TDU Title. The VST/TDU tests will be limited to (4) Golden Retrievers each test. Note: if the limit for entries is not reached in Golden's, other breeds may enter using the following draw procedure. Draw (1) all Golden's without a VST/TDU title; Draw (2) all Golden's with a VST/TDU title; Draw (3) all other breeds without a VST/TDU title; Draw (4) all other breeds with a VST/TDU title. An exhibitor may enter more than one dog. If the limits are not reached in the VST or TDU tests, then the substitution rules will be applied.

TEST WORKER OPTION: At each draw, one (1) track will be set aside per Chapter 1, Section 17d. "Test Worker" is defined as a person who has previously worked at a WRGRC tracking test.

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Entry fee for the TDU test is \$85.00 & VST test is \$130.00 (includes \$0.50 for AKC recording fee and \$1.50 for the AKC event service fee) made payable to White River Golden Retriever Club in US funds. A recording fee of \$0.50 and an event service fee of \$1.50 will be required for each dog entered at any licensed or member club show, or obedience trial, or tracking test. These fees are to be collected by the show-giving club and paid to the American Kennel Club. .

Entries cannot be accepted, canceled, altered or substituted after the entries close with the Tracking Secretary, Laurie Beard.

**The tracking test will be limited to 4 TDU's and 4 VST's dogs.**

Bitches in season will be allowed to run in this test as allowed in AKC Tracking Rules, Chapter 2. In accordance with the AKC Obedience Regulations (AKC Rules, Chapter 1, Section 26a) entries in this VST test shall be accepted up until the official closing date, even though the advertised limit has been reached. The entry participation drawing will be held at the Tracking Secretary's home on October 31, 2019 at 7:00 p.m. to determine which entries will participate in the tests. This drawing shall be conducted in accord with the above procedure. When the advertised limited has been drawn, all remaining entries, subject to the same preference set for above, shall be similarly drawn and assigned a position on the alternate list. The Tracking Secretary shall then notify all entries of the results of the draw. No entry fee will be refunded, except that of an alternate who does not participate and whose entry fee will be refunded within 7 days following the test.

In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the Tracking Secretary to determine if alternates are present, and to determine, by the position on the Alternate list, which of the alternates shall participate.

The assignment of dogs to the tracks, by the drawing of lots, is the responsibility of the judges.
